terms & conditions

Listed below are our terms and conditions for large group bookings at Poachers Pantry (Fumage Pty Ltd ABN 49058335818).

A large group is considered to be 9 or more guests. Confirmation of a large group booking requires a deposit of \$50 per guest, including children under 12 years old. Once the deposit is paid in full, the customer agrees to the following terms and conditions. The deposit is fully refundable in the case of cancellation within 14 days of the booking The deposit is 50% refundable in the case of cancellation within 7 days of the booking

Confirmation of a guaranteed number of guests attending is required 7 days before the booking. This is the minimum number of guests that you will be charged for. If no guaranteed number is received, the original number reserved will be prepared for and charged for, plus any additional numbers.

Booking details and catering requirements are required 7 days before the booking. This includes the estimated number of guests (including children), all dietary requirements, the use of highchairs/prams, and cakeage. Additional labour charges may be incurred by

All cakes must be sourced through Poachers due to food safety requirements. Cakes are made by Sugar Plum Fairy Cakes in Hall, ACT and typically cost around \$130. No outside cakes are allowed.

All large group bookings booked on public holidays or New Year's Eve are subject to a 20% surcharge.

The client is responsible for informing all relevant persons involved in the booking of the company's terms and conditions. This includes sharing the current menu with them in order to determine any dietary requirements.

Poachers adheres to the NSW Liquor Act 2007 No 90. All bookings must comply with our house policy.
